Due to the Coronavirus Disease 2019 (COVID-19) pandemic, the Baltimore City Board of Elections is open to the public by appointment only. Please call **410-396-1444** to make an appointment.

#### **2020 Presidential General Vote Centers**

Limited in-person voting will also be available on November 3, 2020, but this is intended for use by voters who are unable to return their mailed ballots or who never received their ballots. Due to the risk posed by COVID-19, please do not use the in-person voting centers if you are able to mark and return your ballot by mail or at a ballot drop-off location.

# **Drop-Off Boxes, Early Voting Centers, and In-Person Voting Centers**

Ballot drop-off boxes will be open 24/7 through 8:00 pm on Election Day. As a reminder, the oath on the back of the return envelope must still be signed if you are using a ballot drop-off box.

### **HALLOWEEN DURING COVID-19**

In an effort to keep you, your family and others safe this Halloween the Baltimore City Health Department has provided a guide of tips and tricks to minimize your risk of contracting or spreading Covid.

Remember, regardless of age- traditional door-to-door trick-or-treating, indoor house parties, and indoor haunted houses are not advisable during an active pandemic, and can significantly increase the chances of disease transmission!

### Halloween at Home! (No face coverings required)

- Carve or decorate pumpkins with members of your household and display them.
- Carve or decorate pumpkins outside, at a safe distance, with neighbors or friends
- · Decorate your house, apartment or living space
- Have a Halloween movie night with the people you live with
- Host a scavenger hunt-style trick or treat search with your household members in or around your home instead of going house to house

### Halloween outside the Home! (Face covering required)

- Participate in one-way trick-or-treating where individually wrapped goodie bags are lined up for families to grab-and-go while continuing to social distance (such as at the end of a driveway or at the edge of a yard). If you are preparing goodie bags, wash your hands with soap and water for at least 20 seconds before and after preparing the bags
- Host a small group, outdoor, open0air costume parade where people are distanced more than 6 ft apart
- Attend a costume party held outdoors where face coverings are used and people can remain more than 6 ft apart
- Go to an open-air, one-way, walk-through haunted forest where appropriate face covering use is enforced, and people can remain more than 6 ft apart. If screaming will likely occur, greater distancing is advised. The greater the distance the lower the risk of spreading a respiratory virus
- Visit pumpkin patches or orchards where people use hand sanitizer before touching pumpkins or picking apples and people are able to maintain social distancing
- Host an outdoor Halloween movie night with local family and friends with people spaced at least 6 ft apart. Lower your risk by following CDC's recommendations on having gatherings or cook-outs

# **RECYCLING**

As a reminder weekly curbside recycling pickup was suspended beginning Monday, August 31st and will continue through November 1st. Community Collection Centers were established for recycling. These centers consist of a roll-off dumpster/load packers, manned daily and located at central locations in each of Baltimore's 14 City Council Districts. The centers are open from 7 a.m. - 3 p.m. The plan offers a community-friendly partnership to residents that enables DPW to continue recycling collection services without compromising trash collections, which are essential during this time.

Hamilton Hills closest drop-off location is Hamilton Elementary Middle School at 6101 Old Harford Road.

### Recycling Do's and Don'ts

Recycling can be confusing. Can you recycle a mayonnaise container? What about take-out food containers?

Acceptable items include empty and clean aluminum and steel cans (lids can be recycled); cardboard boxes and cartons (flatten boxes); glass bottles and jars; paper, newspaper, magazines and books; and plastic bottles, jars and jugs.

Unacceptable items include trash or yard trim\*; hoses, wires, chains and/or cords\* (no tanglers); no food or food stained paper\*; no styrofoam\*; no textiles (donate clothing, shoes, towels or rugs). \*Place these items with your weekly trash pickup.

Do not bag recyclables! No plastic bags should be in your bin. More information can be found at PublicWorks.BaltimoreCity.gov/Recycling-Services.

# **EMERGENCY FOOD RESOURCES**

In response to the COVID-19 pandemic, the following locations are providing grocery/produce boxes while supplies last:

- Harbel Community Organization, 5807 Harford Road, Wednesdays at 3 pm
- Italian Cultural Center, 315 Homeland Southway, Tuesdays at 12 pm
- Belair Edison School, 3536 Brehms Lane, Thursdays at 10 am

Additionally, Baltimore City is delivering grocery boxes this fall in partnership with the Maryland Food Bank and The Salvation Army of Central Maryland.

### Who Qualifies?

- If you have no food at home or will run out before you can buy more;
- If you can't afford paid meal or grocery delivery;
- If you are experiencing financial, social, or medical hardships due to COVID-19
- If you have someone at home who is able to prepare food

### What Should Qualifying Household Expect?

A household wil receive a grocery box with enough non-perishable food for 1-2 weeks depending on household size. The box will be delivered within 3-4 days of ordering.

### To See if You Qualify

Adults 60 and older should call **410-396-2273**. Residents 59 & younger should call **2-1-1**.

If you don't qualify for home delivery, food assistance is still available. Please visit **Coronavirus.BaltimoreCity.gov/Food-Distribution-Sites** for additional resources and locations for food distribution sites.
